Students are instructed to deposit the amount of **Rupees Twelve Thousand Six Hundred** only by **Bank Draft** in favour of **State Institute of Physical Education for Women** from any bank payable at **Kolkata**. The amount may be deposited by transferring the money through **NEFT** also to the following bank account from **any Bank** or using UPI, G-Pay, BHIM, Pay-tm etc. If the amount deposited through NEFT then the student **must submit the NEFT transaction receipt** to the college office. If the student unable to come to the college office due to pandemic situation she **must sent the soft copy of the NEFT transaction receipt (jpeg or pdf format)** issued by the bank/UPI app to the college's official WhatsApp group. Money Receipt will be issued to the student by the college after verification of the account. The receipt may be collected from the college office by hand.

- 1) Above mentioned Govt. deposit of Rs. 60/- and Tuition Fees of Rs. 100/- per month is to be deposited by cash in the college office which will be submitted to the Govt. Treasury by the college.
- 2) Mess expenses @ Rs. 2000/- per month will be required to deposit to the Matron at the 1<sup>st</sup> week of the each month when mess is on. The students must submit **Rs. 2000/-** as Mess Advance for the starting month to the Matron at the time of reporting to the Hostel of the college.
- 3) Refund shall be made after the end of the session for each section, if any.
- 4) No refund will be made if the students leave the course in between any time of the session.
- 5) Fee structure might be change according to the need and requirement of the students.
